down in UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018

1. Academic reputation and previous performance in university examinations and its academic/curricular/extension activities in the past.
2. Academic/extension / research achievements of the faculty.
3. Quality and merit in the selection of students and teachers, subject to statutory requirements in the regard.
4. Adequacy of infrastructure in terms of class rooms, library books and e-resources, laboratories and equipments, sports facilities, facilities for recreation activities, residential accommodation for faculty and students, transport facilities etc.
5. Quality of institutional management.
6. Financial strength of the institution.
7. Responsiveness of administrative structure.
8. Motivation and involvement of faculty in the promotion of innovative reforms

The affiliating University and the concerned State Government are requested to provide their nominees as per the provisions of the UGC Regulations for autonomous colleges. As per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations 2018, the University will nominate an academicians of repute as its nominee in the UGC Expert Committee at the time of fresh induction and extension of autonomous status to a College within 30 days of the request. If the University does not provide a nominee within 30 days, it shall be presumed that the University has no objection to the processing of the proposal by the UGC for conferment of autonomous status. Moreover, the State Govt. will also provide its nominee in the UGC Expert Committee at the time of fresh induction and extension of autonomous status to a College within 30 days from the issue of this letter.

The UGC Coordinating Officer is requested to coordinate with the Principal of the College, Chairperson and members of the Visiting Committee as well as the nominees of the State Government and the affiliating University for conducting the visit. The Coordinator is requested to submit two hard copies as well as a soft copy of the report along with relevant annexures to take further necessary action. Valid certificates of 2(f) and NAAC/NBA accreditation must also be enclosed along with the report. A pro-forma of the report is enclosed for your ready reference. The visit should be conducted within three months from the date of issue of this letter and the report be submitted immediately.


